The Mississippi Commission on College Accreditation (Commission or MCCA) is the entity within the State of Mississippi legally authorized to approve a list of community, junior and senior colleges, universities and other entities which offer one or more post-secondary academic degrees and are domiciled, incorporated or otherwise located within the State of Mississippi. All such colleges, universities, and other entities must be approved annually by the Commission in order to grant diplomas of graduation, degrees or offer instruction.

Level - categorized by the highest degree offered by an institution:

Level I - Associate Degree as highest degree Level IV - Master's Degree and Education Specialist Degree as highest degree

Level II - Baccalaureate Degree as highest degree
Level III - Master's Degree as highest degree
Level V - Three or fewer Doctoral Degrees as highest degrees
Level VI - Four or more Doctoral Degrees as highest degrees

**Degree** - indicates degrees approved to be offered in MS using the following codes:

A - Associate, B = Baccalaureate, M = Master, ES = Educational Specialist, D = Doctorate.
